## LICENSE AGREEMENT

**DO NOT OPEN THIS PACKAGE OR USE THIS SOFTWARE OR HARDWARE KEY (DONGLE) UNTIL YOU HAVE READ THIS SOFTWARE LICENSE AGREEMENT.**

**BY OPENING THIS PACKAGE (OR AUTHORIZING ANY OTHER PERSON TO DO SO), YOU ACCEPT THE SOFTWARE LICENSE AGREEMENT. IF YOU DO NOT ACCEPT THE TERMS AND CONDITIONS OF THE SOFTWARE LICENSE AGREEMENT, YOU MAY RETURN THE MEDIA PACKAGE AND ALL ACCOMPANYING ITEMS (INCLUDING WRITTEN MATERIALS AND HARWARE KEYS (DONGLES)) TO AWE COMMUNICATIONS GMBH ("AWE") IN BOEBLINGEN, GERMANY.**

### **1. Content of license**

The license comes on a CD-ROM and runs under Windows Vista/XP/2000/NT/ME/98/95. Except of the free trial version all software releases of AWE Communications GmbH are copy-protected. Therefore they are shipped together with an USB hardware key (dongle) or with a license file. The software will not run without the hardware key (dongle) or without the license file.

### **2. Grant of license**

AWE Communications GmbH grants you, the end user, a personal, nonexclusive license of this software on an "as is" basis to use a single copy of this WinProp software package, including any updates or additional software provided by AWE Communications GmbH in connection therewith (the "Software") solely for your own internal use, and solely in accordance with the terms and conditions of this license agreement. You may copy the Software into the memory of any computer, solely as necessary to use the Software in accordance with this license agreement.

### **3. Copyright and Copies**

The Software (including any copy thereof) is owned by AWE Communications GmbH ("AWE") and protected by copyright and patent laws and international treaty provisions. The Software copy is licensed, not sold to you, and you are not an owner of any copy thereof. You may either (a) make one copy of the Software solely for backup or archival purposes, or (b) transfer the Software to a single hard disk provided you keep the original solely for backup or archival purposes. You may not otherwise copy the Software, except as authorized by applicable law, and you may not copy the written materials accompanying the Software. AWE Communications GmbH hereby reserves all rights not explicitly granted in this license agreement. This includes also the right on the source code of the software product.

### **4. Other restrictions**

You may not rent or lease the Software, but you may transfer the Software and accompanying written materials on a permanent basis provided you retain no copies and the recipient agrees to the terms of license agreement. If the Software is an update, any transfer must include the update and all prior versions. You may not modify or translate the Software. You may not reverse engineer, decompile or disassemble the Software, except to the extent expressly authorized by applicable law.



## **5. Limited warranty and remedy**

AWE Communications GmbH ("AWE") warrants the physical media (CD-ROM and hardware-key/dongle) and the physical documentation to be free of defects in material and workmanship for a period of 90 days. AWE also warrants that the Software will perform substantially in accordance with the accompanying materials for a period of 90 days. If AWE receives notification within this warranty period of any such defects and such notification is determined to be correct, AWE will, as its sole option and discretion, repair or replace the media or documentation or provide you a full refund of the purchase price paid, if any. The foregoing is your sole and exclusive remedy and states AWE's entire liability arising out of this warranty. This limited warranty is void if the damage or defect has resulted from accident, abuse or misapplication. To the extent allowed by applicable law, implied warranties on the Software, if any, are limited to ninety (90) days.

## **6. No other warranties**

This limited warranty is exclusive and in lieu of all other conditions and warranties for the software and documentation. AWE Communications GmbH makes no other conditions or warranties, express, implied, statutory or otherwise, and expressly disclaim all other conditions and warranties, including but not limited to implied conditions or warranties of merchantability, fitness for a particular purpose, and noninfringement for the software and documentation, to the fullest extent permitted by applicable law.

## **7. Limited liability**

To the maximum extent permitted by applicable law, in no event and under no legal theory shall AWE Communications GmbH ("AWE") be liable to you for any costs of substitute products, or for any consequential, special, incidental, punitive or indirect damages of any kind arising out of the license of, use of, or inability to use any AWE Software or documentation (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss), even if AWE has been advised of the possibility of such damages. AWE's entire liability and your exclusive remedy shall be, at AWE's option, either (a) return the price paid, if any, or (b) repair or replacement of the Software that does not meet AWE's limited warranty. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. In no event shall AWE's liability exceed the license fee, if any, paid by you. This limitation of liability and risks is reflected in the price of the Software license.

## **8. Term**

This license agreement is effective until terminated. You may terminate it at any time by destroying the Software together with all copies, modifications and merged portions in any form. ## **9. Miscellaneous**

This is the entire agreement between you and AWE Communications GmbH, and supersedes any prior agreement, whether written or oral, relating to the subject matter of this license agreement. The parties disclaim the application of the United Nations Convention on the International Sale of Goods. This license agreement is governed by the laws of the State of Germany. You may not export or re-export the Software or documentation without the appropriate German government licenses. If any provision of this license agreement is ruled invalid, such invalidity shall not affect the validity of the remaining portions of this license agreement.
